Directions

From Hwy 101 in Marin

Take Hwy 37 heading East. Exit at Wilson Avenue (first exit on right after Napa River bridge). Turn left at stop sign off Wilson Ave exit and go east on Wilson. Turn right on Tennessee St. and head west onto Mare Island. Stop at Guard Station and tell them you are going to Building 505 (FWS/USGS offices).

Proceed on G Street. Turn right at T intersection onto Azuar Drive. Turn left on I Street (there is an entrance sign to Refuge). We are meeting in portable offices to southeast of Building 505.

From Hwy 80 in Solano

Take Tennessee Street Exit in Vallejo (follow signs for Mare Island). Head west on Tennessee Street for 2 miles onto Mare Island. Stop at Guard Station and tell them you are going to Building 505 (FWS/USGS offices). Proceed on G Street. Turn right at T intersection onto Azuar Drive Turn left on I Street (there is an entrance sign to Refuge). We are meeting in portable offices to southeast of Building 505.
